# NO ON PROP. 22

Uber, Lyft, Instacart and Doordash wrote Proposition 22 to exempt themselves from state law requiring that app-based companies provide basic worker protections. Now they're spending more than \$180 million on Prop. 22, the most expensive ballot measure in US history, to boost their profits by denying their drivers a minimum wage, paid sick leave and safety protections. Vote No on Prop. 22. It's time to put the safety of drivers and their passengers over corporate greed.



# YES ON PROP. 15

While the wealthiest corporations avoid paying their fair share, our schools have the most crowded classrooms in the nation and our local communities are struggling to respond to the impact of COVID-19. Prop. 15 does not impact any of the protections offered homeowners under historic Prop. 13. Don't believe the lies and propaganda that says it does. Prop. 15 is about fairness to ALL taxpayers and providing the education resources our children need.
